

## REGISTRATION TERMS AND CONDITIONS

**First.-** The participant has registered voluntarily in the TITAN DESERT (hereafter “Event”), organized by RPM RACING S.L.U., based in Av. Diagonal 477, Planta 16, 08036-BARCELONA, with TIN B61514360, (hereafter “RPM”) and wishes to participate in all the activities that take place within it.

RPM reserves the right to refuse admission to any participant, and to modify the route or any of its conditions due to force majeure.

**Second.-** The participant declares to have read and understood all of the race’s rules and regulations and accepts them in their entirety.

The participant has been duly informed by the organization of all the Event details and characteristics, the activities taking place within it, and all risks involved.

The participant has been informed and is aware of the risks involved, and is responsible for any damage or injuries that he/she, those accompanying him/her or third parties may incur, as well as for his/her own material or that belonging to third parties, thus exonerating the organization from all responsibility regarding the damage or injuries that he/she, those accompanying him/her or third parties may incur during the preparation, development or execution of the activity, as well as for the damage to his/her own material or that belonging to third parties, and expressly waives his/her right to make any such claim against the organization or to take legal action against it.

**Third.-** The participant expressly declares that the personal data provided is true and correct, specifically the health information he/she has provided to the organization.

The participant exonerates RPM of any claim resulting from the information provided, as well as from any negative health effects that the participant may suffer due to the falsehood, inaccuracy or omission of health information provided.

**Fourth.-** The participant is aware and accepts that, should the TITAN DESERT be unable to take place for the following reasons: i) impossibility of obtaining the crossing clearances, ii) political complications that may affect any of the countries where the Event takes place, which may pose a risk for the race management and/or for the safety of the participants, iii) organizational and/or administrative aspects (like logistics and finances) which would make it impossible to hold the Event, RPM undertakes to reimburse all amounts paid in these cases, without any possibility of claiming for further damages. Should the Event be suspended for reasons not mentioned above, RPM will not be considered responsible and, as such, no reimbursement will be possible.

Likewise, the participant is informed that, should the Event start date be modified, RPM will immediately contact each and every participant in order to provide them with a new race calendar. From that moment on, participants will have 8 calendar days maximum in which to make a written

request for reimbursement of the registration fee and other amounts paid to the organization. After that time, if the participant has not communicated his/her withdrawal or cancellation, he/she will remain registered in the Event to be held on the new date.

**Fifth.** - The participant is aware and accepts that on the date of his/her registration for the TITAN DESERT, RPM RACING, S.L.U., as organizer of the race, is negotiating with several insurance companies in order to cover accidents and repatriation. The conditions of said coverage will be communicated to the participants when the policy has been finalized by the chosen insurance company.

**Sixth.** - By registering to participate in the Event, the Participant grants RPM, exclusively and free of charge, as well as the authority to grant to third parties, exclusively, the right to obtain and use his/her personal image, name, voice through photographs and/or audio-visual recordings that may be taken collectively or individually, by RPM personnel or by authorized third parties, during his/her participation in the Event, including presentations and award ceremonies, participation in related documentaries as well as any other intellectual and/or industrial property rights that may result from his/her participation in the Event, including, but not limited to, the rights to reproduction, distribution, public communication (including provision) and transformation, for all media and all other known types of exploitation on the date of this Authorization. The Participant is informed that the images may be used for advertising purposes and/or to promote the race itself or its future editions for sales purposes, for commercial purposes, to promote sporting events through any type of media (including social networks, print media and/or audio-visual media), for information, disclosure, promotional purposes, etc. The cession of these rights may be universally carried out during the maximum legally established validity period, and the images will be kept unless the party in question has revoked its consent.

The Participant authorizes for the Event photographs and audio-visual recordings to be ceded to the Event sponsors so they may be used in accordance with the aforementioned terms and conditions for commercial and promotional purposes.

Likewise, the Participant revokes his/her right to receive any type of compensation or payment for the taking and retention of the photographs and audio-visual recordings, as well as for the cession of his exploitation rights, in accordance with the stipulations specified in the present section.

**Seventh.** - RPM RACING S.L.U. based in Av. Diagonal 477, Planta 16, 08036-BARCELONA, with TIN B61514360, as Processing Manager and organizer of the TITAN DESERT will handle all personal data collected for the management of Event registrations for the following purposes:

- To manage Event registrations and the participation in its activities, the execution of the contractual relationship between the participant and RPM being the legitimizing basis for this handling.
- To resolve possible issues regarding the Event, the execution of the contractual relationship between the participant and RPM being the legitimizing basis for this handling.
- To communicate data to our suppliers, as long as it is necessary for the due provision of services, the execution of the contractual relationship being the legitimizing basis for this handling.
- To keep participants informed about RPM events, news and activities, RPM's legitimate interest being the legitimizing basis for this handling.

We will retain your personal data for the time necessary to correctly provide the services related to the Event, in accordance with our legal obligations. Once this data handling has finalized, your personal data will remain blocked and will only be available to the relevant authorities until the responsibilities stemming from this handling finalize, at which point it will be eliminated securely.

The party providing this authorization has the right to:

- Revoke the consent granted, without affecting the legality of the previous handling nor the result of the capture of his/her image and/or voice.
- Obtain confirmation regarding whether or not RPM is handling his/her personal data.
- Access his/her personal data.
- Request the elimination of his/her data when, among other reasons, the data is no longer necessary for the purposes for which it was collected.
- Obtain from RPM the limitation of the data handling when one of the conditions outlined in the Data Protection legislation applies.
- Request data portability.
- Make a claim to the Spanish Data Protection Agency, if the person in question feels that the RPM has breached the rights established in the Data Protection legislation.

**Eighth.** - Image rights. By registering for the Event, the Participant grants and assigns to RPM, free of charge and exclusively, with the power to assign to third parties, exclusively, the right to capture and use their personal image, name, voice through the photographs and / or audio visual recording that, where appropriate, may be made, individually or jointly, through RPM staff or third parties authorized by it, during their participation in the Event, including presentation and award-giving acts , participation in related reports as well as any other intellectual and / or industrial property rights that may arise from your participation in the Event, including, by way of example, but not

limited to, the rights of reproduction, distribution, public communication (including the making available) and transformation, for all means and all forms of exploitation known to the date of this Authorization. The Participant is informed that the images may be used for advertising and / or to disseminate the same test or the following editions and for their sale, and also for commercial purposes, to promote sporting events in any media. (including social networks, print and / or audio visual media), for informational, informative, promotional purposes, etc. This assignment is made during the maximum term of validity of said rights established by law and with universal territorial scope, the images being kept provided that the interested party has not revoked their consent.

The participant authorizes that the photographs and audio visual recordings of the Event be transferred to the sponsors and sponsors of the Event in order to proceed with the exploitation of them, in the terms set forth in the previous paragraph, for commercial and promotional purposes. Likewise, the Participant waives to receive any type of compensation or economic remuneration for the taking and conservation of the photographs and audio visual recordings and for the transfer of their exploitation rights, in accordance with the provisions of this section.
